Channel Farmhouse is a large Grade II listed Victorian farmhouse set in the beautiful East Riding countryside with rural views towards the River Humber.

The property is well proportioned, with a large kitchen/breakfast room, three reception rooms with character features and an open fireplace in the sitting room. The first floor boasts a spacious master bedroom accompanied by an en suite, there are three further bedrooms and a family bathroom.

There is an extensive garden and private gravelled parking area. The property also benefits from oil central heating, outbuildings and an integral garage. The farmhouse was once an integral part of the farming operations at the adjacent farmyard. Outbuildings are available by negotiation.

Directions to HU12 0QW Take the A1033 from Hull, continuing through the villages of Thorngumbald, Keyingham, and Ottringham towards Patrington. In Patrington turn right onto Humber Lane, signposted towards Patrington Haven. Turn right at the 'T' Junction heading through Patrington Haven and after approximately 2.1 miles turn left on to Channel Road, the property is located on the left hand after approximately 0.7 miles and is identifiable by a Frank Hill and Son sale board.







First Floor




Outbuilding
